# This Pandemic Life

In mid-March when
Governor Pritzker
announced the shelter-inplace order, all Institute
operations moved from
our Michigan Avenue
space to distance
technology platforms.
Classes for the education
programs, therapy
sessions in our Treatment
Center, committee

meetings, supervision and consultation, groupwork and therapy to students in schools, community work, administrative business and support—all that the Institute does went virtual within a few days. We were able to accomplish this because of our dedicated faculty, students, therapists and staff and because we have a robust technology platform developed from our experience with global learning.

As I observed this process, I was impressed by everything the Institute does and even more aware of the support of our donors that makes it possible. The Institute relies on philanthropic contributions for all that it does. Revenue from tuition and programming provides 54% of our annual budget and 22% comes from the support of our philanthropic community, a group that understands the Institute's local and global impact. The shortfall is covered by the Institute's reserves. When we teach psychotherapists and psychoanalysts, we not only enable them to become better clinicians, we are also training the teachers, supervisors, consultants and leaders in the mental health field. When we provide feeadjusted clinical services, we not only directly improve the lives of our patients, we also know that they will bring their newly acquired emotional skills to their family, their friends and their colleagues. To do this, we depend on philanthropic support.

A vivid example, described elsewhere in this newsletter,

is the Frontline Responders project which offers pro bono short-term therapy to essential workers who deal daily with the stresses of helping those struck with Covid-19 illness. Though the project runs on the volunteer spirit of our faculty, it also requires considerable background support of the Treatment Center staff. These are costs not immediately obvious, but costs nonetheless. Philanthropic support has made it possible for us to contribute our psychoanalytic expertise to the community in this way during the pandemic.

This year's Annual Benefit could not be held as usual due to the pandemic. We rely on sponsors, tickets and gifts from each year's Benefit to close the gap between tuition, program revenue and expenses. The generosity of sponsors and those who bought tickets to our virtual Benefit meant we raised a significant amount this year, though not what we expected from an in-person event. Perhaps ironically, the theme of this year's Benefit, "Introducing the Future to Freud," would have highlighted the scope of applications of psychoanalytic ideas to businesses and the wider world. Instead, the future looked like a pandemic.

Our philanthropic support comes from people who believe deeply in the Institute's mission, to transform lives by using psychoanalytic knowledge to help them grow and thrive. Please help us expand our philanthropic community by telling friends, family and colleagues about the way psychoanalytic knowledge can improve individual lives and the communities that we share. #### TELETHERAPY:

### Frontline Responders



On Memorial Day, May 25, 2020, the Institute launched "Frontline Responders" a program, led by faculty member Phil Lebovitz MD, that delivers pro bono short-term teletherapy sessions to workers of all kinds on the frontlines of the COVID-19 crisis in Illinois.

During the pandemic, frontline workers are experiencing an intense spike in stress caused by grief, lack of personal protection equipment, isolation from family, friends and support networks, risk of infection or passing along the infection and fear of death. This added pressure increases the risk of anxiety, depression, PTSD, substance abuse and suicidal thoughts.

The Institute's Frontline Responders program is a pro bono service created to treat workers enduring or struggling to deal with these challenges. Illinois frontline workers who email FrontlineWork@ChicagoAnalysis.org or call 312-897-1405 will be put in touch with an appropriate clinician at no charge. Up to 8 treatment sessions will be provided through secure HIPPA compliant videoconferencing. Those who wish to continue therapy will be helped to find resources.

Approximately 45 faculty members volunteered their services for the Frontline Responders program. Calls have come from a variety of people on the frontline, ranging from ER doctors to administrators. This program showcases the Institute's mission to transform the lives of individuals, families and communities using psychoanalytic knowledge to help them grow and thrive.


Saturday, June 6, President Erika Schmidt and Dean Prudence Gourgeuchon

### New faculty & board members



Dr. Wendy Selene PhD, LCSW was appointed Dean of the Institute and began her tenure July 1st. She was the Institute's Director of Conferences and Continuing Education where she was

responsible for the development of the Institute's public education programming. Notable conferences Wendy has organized include events on neuropsychoanalysis and psychoanalytic perspectives on prison mental health, gender and politics. She is a member of the Institute's psychoanalytic education faculty and has presented to professional and community groups on a variety of subjects. Dr. Selene maintains a private practice in Evanston, IL where she offers psychoanalysis and psychoanalytic psychotherapy. Special interests include early and young adult parent loss, trauma and blocked mourning. Dr. Selene received her doctorate from the Institute for Clinical Social Work in 2020. Her dissertation was on young adult parent loss.



## UPDATES AND SAVE THE DATES

#### **SAVE THE DATE:**

#### **FALL SEMESTER CLASSES START -**

Friday, September 11 begins the academic school year. All classes will be held online until it is safe to return to the classroom.



#### **2020 VISION:**

Fall 2020 classes, faculty meetings and continuing education programs will be conducted remotely. This decision will be evaluated as pandemic safety procedures unfold with plans to return to in-person teaching as soon as practical. Treatment Center services and business operations are being evaluated separately. Watch for more news on this front in the coming weeks.

#### **RECORD STUDENT APPLICATIONS:**

Despite the COVID-19 pandemic, applications for the education programs stayed strong. For Fall semester 2020, the Institute received a record number of applicants, locally and from across the globe. Applications came from India, Iran, Saudi Arabia and China as well as Florida, Massachusetts, Alabama, Tennessee and of course Illinois. The launch of the newly developed Integrative Psychoanalytic Couple Therapy program will be deferred until Fall 2021, but all other programs such as Fundamentals of Psychoanalytic Thought, the Psychoanalytic Education Program and the Psychodynamic Psychoanalytic Program will have full classes. The Institute is looking forward to welcoming the incoming class in September.
